# ARTICLES OF INCORPORATION

The undersigned incorporators, for the purpose of forming a corporation under the Florida Not-for-Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

## ARTICLE I

The name of the said corporation shall be: Good Works Baptist Church, Incorporated.

## ARTICLES II

The principal place of business and mailing address shall be: 1822 Saint Catherine Avenue, Pensacola, Escambia County, Florida 32501-1046.

## ARTICLES III

The Specific purpose(s) for which this corporation is organized shall be as follows:

- A) Notwithstanding and other provision of these articles, this organization shall not carry on any activities not permitted under Section 501 (c) (3) of the Internal Revenue Code of 1986 or by an organization exempt from Federal and State income taxes or the corresponding provision of any future United States revenue laws.
- B) The purpose of this organization ( Church) is to promote the Baptist Faith as found in the New Testament of the King James Version of the Bible 1611 Edition. To evangelize and advance the Christian Faith nationally and internationally. To conduct religious services, baptism, wedding, funerals, conferences, revivals, marital workshop and faith-based substance abuse programs.
- C) This corporation will develop the following activities/programs:
  - 1. Develop faith-based agencies to address charitable needs in poor communities.
  - 2. Promote literacy ( Basic education, Higher education and General learning)
  - 3. Advance the Biblical and Secular models of science and its practical applications.
  - 4. Promote ethics and morals that advances testing for public safety.
  - 5. Prevention of cruelty to children.
- D) To work in harmony with the Southern Baptist Convention, Florida Baptist Convention and the Pensacola Bay Baptist Association. To help others Christian evangelism, church planting and church growth.
- E) To guide, direct and control the efforts of Baptist Charities Social Services, Good Work Ministries Thrift Store, West Florida Chamber of Commerce Community Development Corporation and J. Harrison Hunter & Associates Building Maintenance Training Program

## ARTICLE IV

The government of the corporation shall be vested in the Board of Directors who shall be members of the church, tithers, scripturally qualified, publicly professing faith in the Lord Jesus Christ and sincerely following the teaching of the Holy Scriptures. The Pastor, five (5) Deacons, three (3) Trustees and three (3) Women of faith will serve as Board of Directors. The number of directors shall be no more than twelve (12).

- a) The Pastor will be the foremost leader of the Church, an ex-officio member of all committees.
- b) The Board of Directors shall be appointed by the the Pastor from the general membership







## ARTICLE VII

### Dissolution

#### Section 1. Procedure

**The existence of the Spiritual Church of God is everlasting.** However, mortal men do not live forever, therefore we will identify how church funds/assets will be disbursed if the Good Works Baptist Church should dissolve. The church shall use its funds only to accomplish the objects and purposes specified in these articles and bylaws, and no part of said funds shall inure, or be distributed to members of the church. On dissolution of the Church any funds remaining shall be distributed to one or more regularly organized and qualified Southern Baptist Churches, Pensacola Bay Baptist Association, Florida Baptist Convention, Southern Baptist Convention, charitable, educational, scientific, philanthropic or community development corporation to be selected by the Board of Directors.
