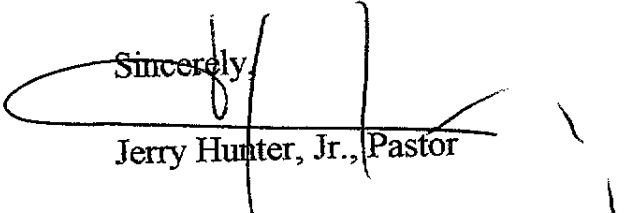

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

FIRST: (Amended) ARTICLE VII

Articles of Dissolution

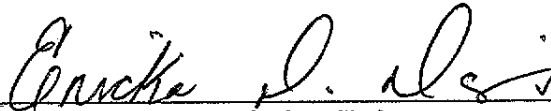
Section 1. Procedure

The church shall use its funds only to accomplish the objects and purposes specified in these articles and bylaws, and no part of said funds shall inure, or be distributed to members of the church. On the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for public purpose. Any such assets not disposed of shall be disposed of by Court of common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

SECOND: The date of adoption of amendment was: **October 14, 2001**

THIRD: Adoption of Amendment
