**Article I**  
**Name**

The name of this corporation is The Good Shepherd Humanitarian Corporation

**Article II**  
**Business Address**

**Article III**  
**Purpose and Power of the Corporation**

The purpose of the corporation is to serve the community, Senior Citizens, Elderly, and Veterans of the City of Lake Worth and of Palm Beach County. This corporation is a non-profit and non-discrimination against any people regardless of race, creed, or color. Provide support and assistance to all immigrants.  
To hold regular meetings, publish, and disseminate information in other ways to keep members informed about assistance in translation. (especially for elderly).  
Help in locating adequate housing.  
Assisting in transportation and employment resources.  
Help to obtain legal citizenship, education in areas of child abuse, domestic violence, code violations, and create youth programs.

The corporation is organized exclusively religious, charitable, literary, and educational within the meaning Section 501 -c-3 of the Internal Revenue Code of 1986 or corresponding provision of any future United State Revenue Code.

Employed personnel to perform the service required for the proper operation for the corporation.

**Article IV**  
**Directors**

- A. **Numbers and Qualifications.** The affairs of this Corporation shall be managed by a board of not less than three (3) not more than nine (9) directors ( the "Board of Directors"), all of whom shall be members of the Corporation. The first Board of Directors shall be comprised of seven (7) persons. The number of Directors within the limits of not less than three (3) nor more than nine (9) may be changed by amendment of the Bylaws determine by in subject to of the Corporation. - D. **Term of Initial Directors.** The first Board of Directors and their replacement shall hold office for the period described in the Bylaws.

**Membership:**

Membership in the Corporation shall be open to all persons who are eighteen (18) years of age or older who:

- A. own a legal residence in the City of Lake Worth, within the area bounded.
- B. The Bylaws may provide for other categories of non-voting membership in the Corporation.
- C. The Boundaries of the Corporation may be changed by amendment of the Bylaws
  - 1. on the North by the West Palm Beach Canal:
  - 2. on the South by 18<sup>th</sup> Ave. South:
  - 3. on the west from the east side of Highridge Road to the east by the Lake Worth Lagoon/ Inter-Coastal Waterway.

All votes shall be cast by the designated members in accordance with the Bylaws, as the same may be amended by time to time.

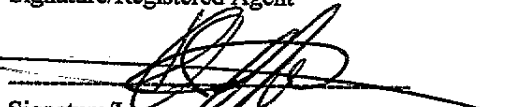
