ARTICLES OF INCORPORATION

OF

BROWARD CARNIVAL INC.

(A FLORIDA NON PROFIT CORPORATION)

I, the undersigned, being a natural person, competent to contract, and acting as an incorporator, do hereby subscribe to the following Articles of Incorporation for the purpose of creating a Not-for-profit Corporation under Florida Statute 617.

ARTICLE 1 – CORPORATE NAME

The name of the corporation is: BROWARD CARNIVAL INC.

ARTICLE 11 – DURATION

The duration of the Corporation is perpetual.

ARTICLE 111 – LOCATION

The initial Board of Directors shall have three (3) members who shall be elected in the manner set forth in the by-laws of the Corporation and may be amended from time-totime as therein provided.

ARTICLE V1 – LIMITATION OF CORPORATE POWERS

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes. The corporation is created in contemplation of meeting all requirements of the Internal Revenue Code 501-(C) (3) and is not for the private gain of any person.
