ARTICLES OF AMENDMENT TO THE ARTICLES OF URIA GOLARB COMMUNITY CENTER, INCORPORATED

ARTICLE ONE. NAME

The name of the corporation shall be changed from URIA GOLARB COMMUNITY CENTER, INCORPORATED to the following: The Change of Name is

URIAH GOLARB COMMUNITY DEVELOPMENT CORPORATION

ARTICLE THREE. PURPOSE

This corporation is a non-profit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Non-profit Public Benefit Corporation law for charitable and educational purposes to aid the poor and disadvantaged individuals and families towards a life of self-sufficiency. The public benefit corporation can lend money or it can establish certain programs to aid and assist the disadvantaged. These programs will consist of, but shall not be limited to the following:

- A. Establishment of Day Care Programs
- **B.** Job Training Initiatives
- C. Job Placement Assistance
- D. Land Acquisition Housing for the needed
- E. Employment Opportunities
- F. Literacy Programs
- G. Counseling Activities
- H. Temporary Shelter for the Homeless
- I. Teenage Pregnancy
- J. Substance Abuse Awareness and Prevention
- K. Tutoring Assistance
- L. AIDS Counseling and Testing
- M. Elderly Care
- N. Other programs to aid those in Need

ARTICLE FOUR. MANNER OF ELECTION

The manner in which the officers and directors are elected or appointed to serve this Nonprofit Public Benefit Corporation is controlled by the Bylaws of the entity.

ADDITIONAL ARTICLES TO THE CORPORATION

ARTICLES SIX. NATURE OF ENTITY

This Corporation is organized and operated exclusively for Religious, Charitable and Education purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code.

Notwithstanding any other provision of theses Articles, the corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or by a corporation contributions to which are deductible under Section 170 (c)(2) of the Internal Revenue Code.

ARTICLE SEVEN. ASSETS

The property of this corporation is irrevocably dedicated to Charitable and Educational purposes and no part of the net income or assets of the organization shall ever inure to the benefit of any director, officer or member thereof or the benefit of any private person.

ARTICLE EIGHT. DISSOLUTION

On the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment of, all debts and liabilities of this corporation, shall be distributed to a nonprofit fund, foundation, or corporation, which is organized and operated exclusively for, Religious, Charitable and Education under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose.

Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
