ARTICLES OF INCORPORATION  
OF

ARTICLE I

The name of the corporation is: . . . . .

The corporation is organized pursuant to the Florida Not For Profit Corporation Act.

(2) The general purpose and powers of the corporation are to have and exercise all rights conferred on a not for profit corporation under the laws of the State of Florida, or which may hereafter be conferred, including the powers of contract, lease, buy, sell personal or real property.

The street address of the principal office of the corporation and its mailing address shall be 6671 W. Indiantown Road Suite 56-386, Jupiter FL 33458.


**ARTICLE V**
