**ARTICLES OF ORGANIZATION FOR
NEW PATHWAY INSTITUTE, INC.**

**ARTICLE ONE
NAME**

The name of this not-for-profit company shall be New Pathway Institute, Inc.

**ARTICLE TWO
PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be:

**ARTICLE THREE
DURATION**

This not-for-profit corporation shall commence its existence immediately upon the filing of these Articles of Incorporation and shall exist perpetually thereafter unless sooner dissolved according to law.

**ARTICLE FOUR
PURPOSE AND POWERS**

The purpose for which the corporation is organized is to provide a therapeutic residential adolescent facility. Except as may be further restricted by these Articles of Organization, this not-for-profit corporation may exercise all powers and rights which a not-for-profit corporation may exercise under Florida law or the laws of the United States of America, including Internal Revenue Service Code Section 501(c)(3).

AMENDMENT

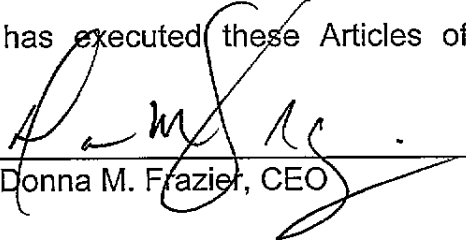

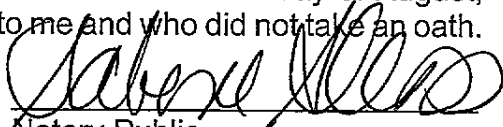
