# ARTICLES OF INCORPORATION

*The undersigned, acting as incorporator(s) of a corporation pursuant to Chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:*

## ARTICLE I - Name

The name of the corporation shall be:

## ARTICLE II - Principal place of business and mailing address

## ARTICLE III - Purpose(s)

The specific purpose(s) for which the corporation is organized is (are):

SAID CORPORATION IS ORGANIZED EXCLUSIVELY FOR CHARITABLE, BENEVOLENT, ELEEMOZY-  
NARY, EDUCATIONAL, HISTORICAL, CIVIC, PATRIOTIC, RELIGIOUS, SOCIAL, LITERARY,  
CULTURAL INCLUDING ALL EXCEPT ANYTHING NOT PERMITTED UNDER A NON-FOR-PROFIT  
LAWS.

## ARTICLE IV - Manner of election of directors

THE BOARD OF DIRECTORS SHALL BE ELECTED OR APPOINTED IN ACCORDANCE WITH THE  
BYLAWS. THE INITIAL BOARD OF DIRECTORS ONLY UNTIL THE FIRST MEETING SHALL HAVE  
THREE (3) MEMBERS WHOSE NAMES AND ADDRESSE INDICATED IN ARTICLE VII.

## ARTICLE V - Limitation of corporate powers

The corporate powers of this corporation are as provided in section 617.0302, Florida  
Statutes, unless limited as follows:

THE CORPORATION NOT FOR PROFIT SHALL HAVE THE FOLLOWING CORPORATE POWERS, INCLU-  
DING BUT NOT LIMITED TO: CONDUCT ITS AFFAIRS, CARRY ON ITS OPERATIONS, AND HAVE  
OFFICES AND EXERCISE THE POWERS GRANTED BY THIS ACT IN ANY STATE OR TERRITORY.

ARTICLE V-B: DISSOLUTION

UPON WINDING UP AND DISSOLUTION OF THE CORPORATION, THE REMAINING PROPERTY AND ASSETS SHALL BE DISTRIBUTED FOR ONE OR MORE EXEMPT PURPOSES WITHIN THE MEANING OF SECTION 501 (c) (3) OF THE INTERNAL REVENUE CODE, ( OR THE CORRESPONDENCE SECTION OF ANY FUTURE TAX CODE), OR SHALL BE DISTRIBUTED TO THE FEDERAL GOVERNMENT OR TO A STATE OR LOCAL GOVERNMENT FOR A PUBLIC PURPOSE.

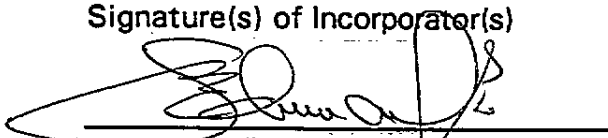
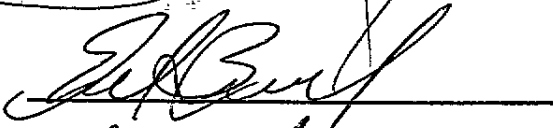
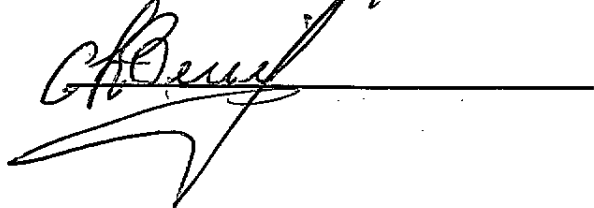
