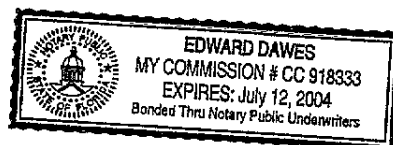

**ARTICLES OF INCORPORATION
OF CHILDREN'S CONNECTION, INC.**

The undersigned, acting as the incorporator of a not-for-profit organization under the Florida Not for Profit Corporation Act, as set forth in Chapter 617 of the Florida Statutes, as amended, adopt the following Articles of Incorporation for such Corporation:

ARTICLE 1- NAME

The name of the Corporation shall be: **CHILDREN'S CONNECTION, INC.**, hereinafter referred to as the "Corporation".

ARTICLE 2- PRINCIPAL OFFICE AND MAILING ADDRESS

The principal place of business and mailing address of this Corporation shall be: 20002 N.E. 6th Court Circle, North Miami Beach, Florida 33179.

ARTICLE 3- PURPOSES

The Corporation is organized and operated exclusively for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended.




