ARTICLES OF INCORPORATION

ARTICLES OF INCORPORATION

ARTICLE I

SECRETARY OF STATE
TALLAHASSEE FLORIDA

The name of the corporation shall be ST. LAWRENCE COMMUNITY CHURCH INCORPORATED.

ARTICLE II

The principal office of the ST. LAWRENCE COMMUNITY CHURCH INCORPORATED, shall be 4881 Clyde Dr., CITY of JACKSONVILLE, the STATE of FLORIDA, and the COUNTY of DUVAL.

ARTICLE III

The purposes for which the corporation is organized are: to operate exclusively for religious, charitable, educational, and distinct ecclesiastical purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1986, or the corresponding provision of any future United States Internal Revenue law thereto, and such purposes shall include the following:

I. Religious.

II. To conduct a local church by the direction of the Lord Jesus Christ and under the leadership of the Holy Spirit in accordance with all of the Commandments and provisions as set forth in the Holy Bible, the irrevocable Word of God. Pursuant thereto, the following activities and guidelines shall be established:

- A. A recognized Creed; Code of Doctrine, discipline and form of worship shall be established.
- B. An ecclesiastical form of government shall be established.
- C. Ordination of ministers upon completion of the prescribed course of study, designated by this church ministry.
- D. An organization of ministers shall be established to minister to the congregation of ST. LAWRENCE COMMUNITY CHURCH INCORPORATED.
- E. Establishment of a congregation membership based upon acceptance of a recognized creed and belief and support of the church.
- F. Spread the Word of the Gospel through seminars, radio, television, establishment of church literature, and other forms of mass media for the purpose of educating the individual in the Word of God.
- G. Establishment of various religious services pursuant to the recognized Creed, form of worship, code of doctrine and discipline of the church and the establishment of Sunday Schools and religious schools for Christians and educational instruction to the young and to the old.

III. Minister the Word of God to the faithful, and all others.

IV. Promote and encourage, through the ministry of the organization, cooperation with other organizations ministering within the community.

V. To acquire and hold such property, either real or personal, for church purposes, as may be necessary for its membership and the worship of God.

ARTICLE IV

The manner in which future directors are elected shall be by a majority vote of the already established directors. As positions become needed elections for those positions shall take place. A Board of not less than three members shall manage the business and property of the Corporation, although not limited to three. The present Directors now duly constituted shall constitute the Board of Directors. Directors will be elected by the Pastor.

ST. LAWRENCE COMMUNITY CHURCH INCORPORATED, Board of Directors shall manage the business and property of the church. The present Directors shall hold offices until further election. In the event of the inability of any Director to act, or in the event of the death of a Director, the remaining Directors shall elect another Director to fill the vacancy or vacancies, thus created. Each Director shall be a member in good standing of the corporation. The Board of Directors reserves the right to amend these Articles and the By-laws by a majority vote. This is to be done to further meet the needs of the corporation.

ARTICLE V

ST. LAWRENCE COMMUNITY CHURCH INCORPORATED, is organized under a non-stock basis.

In accordance with and in addition to the powers conferred by the laws of the State of FLORIDA, the Non-profit Corporation shall have the following powers:

- I. To receive and accept gifts of money and property and to hold the same for any of the purposes of the Corporation and its work.
- II. To raise and assist in raising funds for the purposes herein set forth, including the issuance of bonds or other instruments of credit.
- III. To acquire, own lease, mortgage, and dispose of property both real and personal.
- IV. To conduct and carry on religious services and instruction through the public media, including electronic broadcasting, AM and FM radio, telecasting, microwave distribution, closed circuit transmission, and cable television.
- V. To acquire, own and operate such broadcasting and or telecasting facilities.
- VI. To accept property and donations in trust for religious or charitable purposes.




