**ARTICLES OF INCORPORATION  
OF  
NEASE BAND BOOSTERS, INC.  
(A Corporation Not for Profit)**

The Articles of Incorporation of the undersigned, who is a citizen of the United States, desiring to form a not-for-profit Corporation under Chapter 617, of the not-for-profit Corporation Laws of Florida, does hereby certify:

**ARTICLE I:** Name. The name of the corporation shall be **NEASE BAND BOOSTERS, INC.**

**ARTICLE II:** Principal Place of Business. The place in this state where the principal office of the Corporation is to be located is 10550 Ray Road, St. Augustine, Florida 32095 with the mailing address being the same.

**ARTICLE III:** Purposes. The sole purpose for which this corporation is organized is for educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code. The corporation shall be operated exclusively and in furtherance of such purpose.

**ARTICLE IV:** Dedication and Distribution of Assets. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**ARTICLE V:** Board of Directors. The number of initial directors of this corporation is five (5). The manner in which the directors are appointed will be as stated in the bylaws of the corporation. Their names and addresses are as follows:

**ARTICLE VIII:** Term of Existence. The period of duration of this corporation is perpetual.

**ARTICLE IX:** Dissolution. Upon the dissolution of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
