ARTICLES OF INCORPORATION
of

KNOW ALL MEN BY THESE PRESENTS:

That we, being natural persons of the age of 21 years or more, being desirous of researching, educating, and supporting the septic tank system as an environmentally acceptable method of on-site waste water disposal to the public, for the purpose of forming a not-for-profit corporation under and in accordance with the laws of the State of Florida, DO HEREBY CERTIFY:

ARTICLE I - NAME: The name of the corporation is **SAVE OUR SEPTIC SYSTEMS COMMITTEE, INC.**

ARTICLE II - PRINCIPAL OFFICE: The address of the principal office is 2422 Juniper Place, Sarasota, FL 34239.

ARTICLE III - PURPOSE: The purposes for which the corporation is organized are:

- (A) The research into facilities and methods of acquisition and operations of public waste water utilities, education of the public concerning waste water disposal systems, and supporting the retention of septic tank systems as an environmentally acceptable on-site waste water system.
- (B) No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, officers, incorporators or any other private persons, except that the corporation shall be allowed to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the preceding Article (A) hereof.
- (C) The doing of any and all things necessary and incident to the performance of the purposes above set forth insofar as the same are permissible under the statutes governing this corporation.

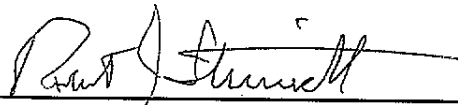
ARTICLE IV - MANNER OF ELECTION: The Directors and members shall be elected as provided in the By-Laws.

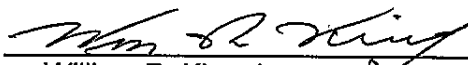
ARTICLE VIII - DURATION: The duration of the corporation shall be perpetual.

ARTICLE IX - MEMBERS: Membership is not limited or restricted by reason of color, gender, ethnic origin, or sexual preference.

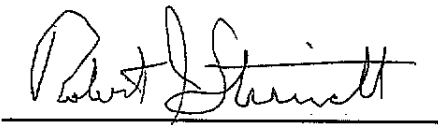
