**ARTICLES OF INCORPORATION
FOR
NATIONAL COMMISSION ON LAW ENFORCEMENT INTEGRITY, INCORPORATED**

The undersigned incorporators, for the purpose of forming a not for profit corporation pursuant to Chapter 617, Florida Statutes, hereby adopt the following Articles of Incorporation. This corporation shall have all the statutory powers of a corporate not for profit except where variations permitted by law appearing in these articles.

ARTICLE I CORPORATE NAME

The name of the corporation is the NATIONAL COMMISSION ON LAW ENFORCEMENT INTEGRITY, Incorporated. The principal place of business of this corporation shall be: 135 East Bahama Rd., Winter Springs, Florida.

ARTICLE II TERM OF EXISTENCE

The Corporation shall exist perpetually unless dissolved according to Florida Law.

ARTICLE III NATURE OF BUSINESS

This Corporation may engage in or transact any or all lawful activities or business permitted under the laws of the United States, the State of the United States, the State of Florida, or any other state, county, territory or nation.

The purposes for which the corporation is organized are exclusively religious, charitable, scientific, charitable, scientific, literary and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal revenue Law.

Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under section 502(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

The National Commission on Law Enforcement Integrity will provide education and training programs to enhance professionalism through ethical standards and corruption prevention training. It will implement services through Internet training programs. The activities of the Commission will be directed toward improving the level of ethical conduct for individuals and law enforcement organizations.

The National Commission on Law Enforcement Integrity will serve as a library and clearinghouse for information, educational and training activities on material related to professionalism through ethical standards and corruption prevention training.

The National Commission on Law Enforcement Integrity will carry on historical research into ethical systems, especially investigating the causes of and solutions for corruption.

ARTICLE IV STOCK DECLARATION

This corporation is organized under a non-stock basis.

ARTICLE V INITIAL BOARD OF DIRECTORS

This corporation shall have three (3) directors initially. The number of directors may be either increased or diminished from time to time by the By-Laws, but shall never be less than three (3). The names and addresses of the initial directors of the corporation are as follows:

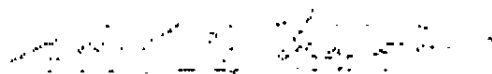
