ONE: The name of the corporation is THE ARK OF JESUS-CHRIST, INC.

The address for the principal office is 619 53rd Street; West Palm Beach, Florida 33407. The corporation is organized pursuant to the FLORIDA Nonprofit Corporation Code.

TWO: This corporation is a CHURCH MINISTRY and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law to spread the Gospel of Jesus-Christ, charitable, and educational purposes to aid the poor and disadvantaged individuals and families towards a life of self-sufficiency. The programs will consist of but shall not be limited to: Preaching, ordain ministers, officers, and Deacons to work for the Ministry of Jesus Christ, Land Acquisition, Literacy, Counseling, and other programs to aid those in need.

THREE: The duration of this corporation shall be perpetual, and shall have no stock.




