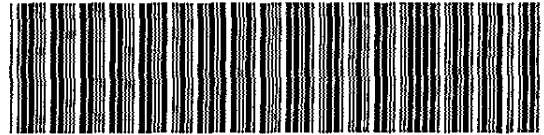



ARTICLE VIII - PROHIBITED ACTIONS

Notwithstanding any other provisions of these Articles of Incorporation or the laws of the State of Florida, effective since the date of incorporation, the Corporation shall not undertake any of the following actions:

- i) permit any part of the Corporation's net earnings to inure to the benefit of any private individual (except that reasonable compensation may be paid for personal services rendered to or for the Corporation affecting its purpose);
- ii) devote more than an insubstantial part of its activities to attempting to influence legislation by propaganda or otherwise; or
- iii) participate in, or intervene in, directly or indirectly, any political campaign on behalf of any candidate for public office.
