A Corporation Not-for-Profit

We, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation not-for-profit under Chapter 617, Laws of the State of Florida, providing for the formation, liability, rights, privileges, and immunities of a corporation not-for-profit.

ARTICLE I - NAME

The name of this corporation is **IMMOKALEE OPTIMIST CLUB, INC.**, a corporation not-for-profit, located at 706 Jefferson Avenue, Immokalee, Florida 34142.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE

The general purpose of the corporation is to maintain and support civic activities within the Community of Immokalee, Collier County, Florida.

ARTICLE IV - QUALIFICATION OF MEMBERS

Members of this corporation shall be any person who desires to be a member and is willing to abide by the rules and regulations of the club.

ARTICLE V - VOTING RIGHTS

Each member is entitled to one vote at Corporation meetings.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT

The street address of the principal place of business is 706 Jefferson Avenue, Immokalee, Florida 34142. The street address of the initial registered office of this corporation is 2725 State Road 82, Immokalee, Florida 34142, and the name of the initial registered agent at the address is **JANET WHIDDEN.**

ARTICLE VII- INCORPORATOR

The name and address of the Incorporator signing these articles is **JANET WHIDDEN** at 2725 State Road 82, Immokalee, Florida 34142.

ARTICLE VIII - INITIAL DIRECTORS

This corporation shall have eleven (11) Directors constituting the initial Board of Directors. The number of Directors may be either increased or decreased from time to time by the Bylaws but in no event shall be less than six (6). In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Sections 501 (c)(3) and 170 (c)(2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future law, or to the Federal, State or local government for exclusive public purpose.

ARTICLE XI - AMENDMENT OF BYLAWS

Any amendments to the bylaws of this corporation may be made at any regular or special meeting of the members by a notice of such amendment, stating the proposed change, shall have been give to those members at least thirty (30) days prior to such meeting.

ARTICLE XII - AMENDMENT OF ARTICLES

This corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the members is subject to this reservation. Amendments may be made at any regular or special business meeting of the Board of Directors by a majority vote of those directors present and voting, providing notice of such amendment stating the proposed change shall have been given to the directors at least thirty (30) days prior to such meeting.
