## **ARTICLES OF INCORPORATION**

The undersigned, acting as incorporators(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

### **ARTICLE I –The Name of Corporation**

The name of the corporation shall be “Changing Your Life Ministry, Inc.

### **ARTICLE II- Principal Place of Business and Mailing Address**

The principal place of business and mailing address of this corporation shall be as follows:

### **ARTICLE III- the purpose(s) for Corporate Organization:**

The mission or main purpose of the corporate entity is to spread the Gospel of Jesus Christ throughout the world by touching the lives of those who are willing to hear the “Good News” and willing to submit to the changing effect which it can have on their lives. The “Ministries” consist of affiliated organizations, “Block At A Time (B.A.A.T.)”, “Joshua Broadcasting Network”, “Unity Walk”, “Changing Your Life Human Resources”, Destin Child Day Care & Learning Centers”, “Hurricane Johnson Ministries”. These subsidiaries will operate under auspices of “Changing Your Life Ministry” which will function as the vanguard or parental organization charged with the primary responsibility to carry out the overall mission of organization.

### **ARTICLE IV-Manner of Election of Directors**

The board of Directors will be elected in accordance with the established Bylaws of the Corporation (Changing Your Life Ministry, Inc.)

### **ARTICLE V-Limitation of Corporate Power(s)**

The Corporate powers of this Corporation are as provided I section 617.0302, Florida Statutes, unless limited as stated in the Corporations’ Bylaws.

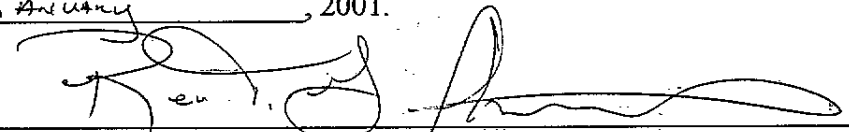

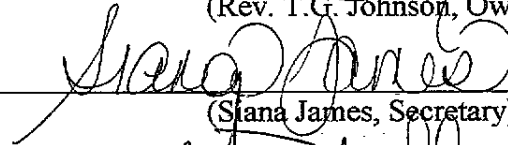

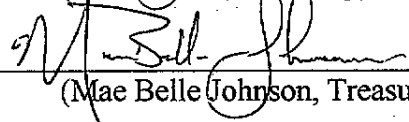

### **ARTICLE VIII- Dissolution of Corporation**

Upon dissolution of the corporation, assets shall be distributed for one of more exempt purpose(s) within the meaning of Section 501 (C)(3) of the Internal Revenue Code (IRC), of the corresponding section of any future tax code, or shall be distributed to the federal government or to a state or local government for public purpose. Any such assets not so disposed of shall be disposed of by court of competent jurisdiction of the county in which the principle office of the corporation is then located, exclusively for such purposes or to such organization of organizations, as said court shall be determine, which is organized and operated exclusively for such purposes.

### **ARTICLE IX- Prohibitions**

No part of the net contribution and support of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private person(s), except the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in the preceding articles hereof. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under section 501 (C)(3) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United States Internal Revenue Law.

### **ARTICLE X-Voting Power of the Board**

Management of the Corporation shall be elected in accordance with the Bylaws. All corporate power shall be exercised by or under the authority of the Board of Directors, and the management of the corporation shall be controlled by the Board of Directors. The officer of the Corporation shall consist of a Chairperson of the Board, an Executive Vice Chairperson of the Board, a President/C.E.O., who shall be entitled to vote, a Corporate Secretary, a Treasurer, and may include up to two (2) other such officers as shall from time to time be designated by the Board of Directors. The President/C.E.O. may hold the position of Chairperson of the Board of Directors simultaneously. Officers shall hold office, until the date fixed in accordance with the Bylaws for the annual meeting of the Board of Directors next following the election of such officers and until their successors are elected and agree to serve.

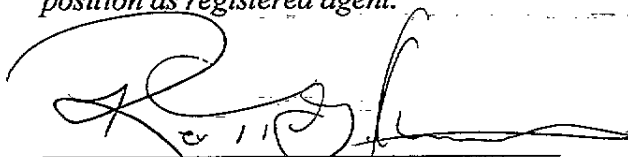

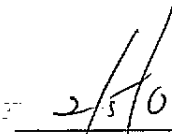
