ARTICLES OF INCORPORATION
OF

BUDDHA'S LIGHT INTERNATIONAL ASSOCIATION, INC., FLORIDA CHAPTER

A NOT FOR PROFIT CORPORATION

The undersigned incorporator makes, subscribes, acknowledges and files with the Department of State of the State of Florida these Articles of Incorporation for the purpose of forming a corporation not for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation is: Buddha's Light International Association, Inc., Florida Chapter.

ARTICLE II - TERMS OF EXISTENCE

This corporation shall commence as of the date of the complete execution and acknowledgment of these Articles or if these Articles are filed more than five (5) days after the complete execution of these Articles, then this corporation shall commence as of the date of filing, and the duration of the corporation's existence shall be perpetual.

ARTICLE III - NATURE OF THE BUSINESS

A. This corporation is organized and operated exclusively for religious purposes within the meaning of Section 501(c)(6) of the Internal Revenue Code.

B. No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.

ARTICLE IV - MEMBERSHIP

Membership in the corporation shall be regulated by the by-laws.

ARTICLE V - INITIAL REGISTERED OFFICE

ARTICLE VI - BOARD OF DIRECTORS

There shall be a Board of Directors for this corporation which shall consist of not less than three (3). Except for the number constituting the initial Board of Directors, the number of directors may be increased or diminished from time to time by the By-Laws adopted by the Board of Directors and the membership. The board of directors are elected according to the bylaws.

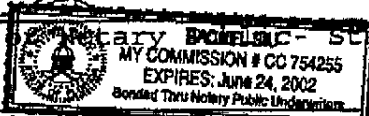
