### ARTICLES OF INCORPORATION

780 Fifth Avenue South Condominium Association, ISECRETARY OF STATE

A Florida Corporation Not For Profit

The undersigned hereby submits these Articles for the purpose of forming a corporation not for profit under Chapter 617, Florida Statutes, and certifies as follows:

#### ARTICLE I Name

The name of the corporation shall be 780 Fifth Avenue South Condominium Association, Inc., which corporation shall herein be referred to as the "Association", and whose principal place of business shall be 365 Fifth Avenue South, Suite 201, Naples, Florida 34102.

### ARTICLE II Purpose

The purpose for which the corporation is organized is for the operation and management of condominium buildings and grounds for the use and benefit of the owners of the Condominium Units located in Naples, Collier County, Florida, known as 780 Fifth Avenue South, a Condominium, and any other purpose permitted under Florida Law.

## ARTICLE III Corporate Existence

This Association shall continue to exist so long as the Condominium known as 780 Fifth Avenue South, a Condominium, shall be in existence.

#### ARTICLE IV Directors

1. The business of this Association shall be conducted by a Board of Directors having not less than three (3) nor more than seven (7) Directors as shall be determined by the Bylaws.
