OF THE ARTICLES OF INCORPORATION

OF

Pursuant to Sections 617.1001,617.1002 and 617.1006 of the Florida Not for Profit Corporation Act, MARINE YOUTH SERVICES FOUNDATION, INC. hereby adopts the following Amendment to its Articles of Incorporation.

1. Article VII is hereby amended to read as follows:

ARTICLE VII

Board of Directors

This Corporation shall have three (3) Directors initially. The number of Directors may be either increased or diminished from time to time in accordance with the Bylaws, but shall never be less than three (3).
