FIRST:

ARTICLE I – (removed)

ARTICLE I – (adding new Article I – NAME AND PLACE OF BUSINESS)

The name of this Corporation shall be **LAS PISADAS DEL MAESTRO ASAMBLEAS DE DIOS, INC.** with its principal place of business located at **3400 74th Avenue North Pinellas Park, FL 33781**

SECOND:

ARTICLE II – (removed)

ARTICLE II – (adding new Article II – PURPOSE AND PREROGATIVES)

The general nature and object of this corporation is for the purpose of establishing and maintaining a place for the worship of Almighty God, our Heavenly Father, to provide for Christian fellowship for those of like precious faith, where the Holy Ghost may be honored according to our distinctive testimony; to assume our share of responsibility and the privilege of propagating the gospel of Jesus Christ by all available means, both at home and in foreign lands; we, whose names appear upon the roster of the LAS PISADAS DEL MAESTRO ASAMBLEAS DE DIOS, INC. as of the day of this signing, do hereby recognize ourselves as a local assembly in fellowship with and a part of the General Council of the Assemblies of God, with headquarters at 1445 Boonville Avenue, Springfield, MO and in fellowship with and a part of the Southeastern Spanish District Council of the Assemblies of God, with headquarters at 830 California Woods Circle, Orlando, FL, and adopt the following articles of church order and submit ourselves to governed by them.

To build, construct, erect, maintain mission stations and mission churches, pastor's home and such other houses or equipment as the corporation may desire for carrying on its work.

To receive, administer, disburse and/or invest gifts, and requests by or from any persons or corporations.

This corporation is further organized for the purpose of holding the title to such property or properties as the LAS PISADAS DEL MAESTRO ASAMBLEAS DE DIOS, INC., shall from time to time purchase or acquire and it shall have power from time to time to make such contracts and do such things as shall be authorized and directed by its members. This corporation shall have the power to mortgage, sell, encumber deed or otherwise dispose of any property which may belong to LAS PISADAS DEL MAESTRO ASAMBLEAS DE DIOS, INC.

This assembly shall have the right to govern itself according to the standards of the New Testament Scriptures. "Endeavoring to keep the unity of the faith and of the knowledge of the son of God, unto a perfect man, unto the measure of the stature of the fullness of Christ" Ephesians 4:3, 13.

THIRD:

ARTICLE III – (removed)

ARTICLE III – (adding new Article III – AFFILIATION)

While maintaining its inherent rights to sovereignty in the conduct of its own affairs, this assembly shall voluntarily enter into full cooperative fellowship with assemblies of like precious faith associated in the Southeastern Spanish District, with headquarters in Orlando, FL, and the General Council of the Assemblies of God with headquarters in Springfield, MO; and shall share in the privileges and assume the responsibilities enjoined by that affiliation in Article VI Section 1 of the General Council of the Assemblies of God and in Article XI, Section 2, letter a, of the Southeastern Spanish District of the Assemblies of God Bylaws.

FOURTH:

ARTICLE IV - (removed)

ARTICLE IV - (adding new Article IV – MEMBERSHIP)

The members of the corporation shall be all members in good standing at any given time of said Church Corporation of Florida, provided, however, neither the incorporators nor the members of the corporation shall have any vested right, interest, or privilege of, in or to the assets, functions, affairs or franchises of this corporation, or any right, interest of privilege which may be inheritable, or shall continue after his membership ceases in the a forenamed corporation. This corporation shall not have the power to buy, mortgage, sell, encumber of deed or dispose of any property which it may acquire, without the consent or the direction of a two-thirds (2/3) majority vote of the members, or its successor.

FIFTH:

ARTICLE V - (removed)

ARTICLE V - (adding new Article V – TERM)

The assets of this corporation are dedicated to religious purposes as stated in Article II of these Articles of Incorporation. In the event of the dissolution of the corporation and church, the Administrative Board shall supervise the process of disposal and sale of all property, with the purpose of providing for the payment of all its debts and financial obligations. The remaining proceeds (capital) derived there from shall be disbursed in accordance to the local Constitution of said Church.

SIXTH:

ARTICLE VI – number change to, ARTICLE VIII – DISSOLUTION also (AMENDED)

In the event this corporation shall cease to function for the purposes herein set forth, then all property, real or chattel, shall revert to the Southeastern Spanish District of the Assemblies of God, Inc., under whose supervision this church functions, or to the parent body, the General Council of the Assemblies of God, a Missouri Corporation with headquarters at Springfield, Missouri. The Southeastern Spanish District and/or the General council shall have full authority to sell such property and to use the proceeds derived there from for the extension of the work of the Spanish Assembly of God specially those churches that this corporation may have established as daughter churches.

ARTICLE VI – (removed)

ARTICLE VI – (adding new Article VI – SUBSCRIBERS)

The name and places of residence of the original incorporators and subscribers to these Articles were established with the initial submission of Articles of Incorporation

EIGHT:

ARTICLE VII - (removed)

ARTICLE VII – (adding new Article VII – OFFICERS)

The officers who are to manage the affairs of this corporation shall be as follows: A President, a Secretary, and a Treasurer, which three officers shall be the officers of the corporation, and such other officers, as shall be provided for in the Constitution and Bylaws, all of whom shall constitute and be the Official Board of Directors.

They shall be elected from time to time in accordance with the Constitution and Bylaws and each shall hold office until his successor is elected and ratified at its regular annual meeting. The President shall sign and the Secretary shall attest all legal contracts authorized by the members of this corporation and the laws of the State of Florida.

NINETH:

ARTICLE IX - (removed)

ARTICLE IX – (adding new Article IX – CONSTITUTION AND BYLAWS)

This Corporation shall have the power to govern itself in accordance to its Constitution and Bylaws. The Constitution and Bylaws may be amended in the following manner; every amendment must first be approved by the Pastor and the Official Board of Directors. Then at a member's business meeting called for that purpose, be approved by two-thirds (2/3) vote of those present.
