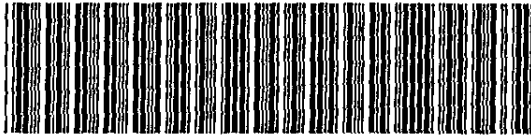

The Officers shall be elected by a majority vote of the Members of this Corporation.


ARTICLE 6 – PRINCIPAL OFFICE (amended)
