ARTICLES OF INCORPORATION

SECRETARY OF STATE

OF

PUBLIC SERVICE ANNOUNCEMENT ORGANIZATION, INC.

A NON-PROFIT CORPORATION

Pursuant to Chapter 617.0202, F.S. the undersigned incorporators hereby adopt the following Articles of Incorporation:

ARTICLE ONE: The name of this corporation is : Public Service Announcement Organization, Inc.

ARTICLE TWO: The principal place of business is 333 Fluvia Avenue, Coral Gables, FL 33134. The mailing address for the corporation is PO Box 145291, Coral Gables, FL 33114-5291

ARTICLE THREE: The specific purposes for which this corporation is organized are: To better our society by creating awareness and provide solutions to social issues through sustained and targeted media placement of public service announcements.

This corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE FOUR: The manner in which the Directors are elected or appointed are: Directors are selected based on their practical qualifications, their community relations value, and their proven commitment to our interests.

ARTICLE FIVE: The number of initial directors of this corporations is 4. Their names and address are as follows:

Any additional provisions for the operation of the corporation are as follows:


1. The period of duration of this corporation is perpetual.
2. This corporation shall have one class of membership. Any person shall be qualified to become a member upon payment of the initial dues, if any, fixed by the board of directors and shall continue as a member upon paying the annual dues, if any, fixed by the board of directors. The method and time of payment of dues shall be determined, and may be changed, from time to time, by the board of directors. Additional provisions specifying the rights and obligations of members shall be contained in the Bylaws of this corporation pursuant to, and in accordance with, the laws of this state.
3. Upon the dissolution of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or shall be distributed to the federal government, or to a state or local government, for a public purpose.
4. In any taxable year in which this corporation is a private foundation as described in Section 509(a) of the Internal Revenue Code, the corporation 1) shall distribute its income for said period at such time and manner as not to subject it to tax under Section 4942 of the Internal Revenue Code; 2) shall not engage in any act of self-dealing as defined in Section 4941(d) of the Internal Revenue Code; 3) shall not retain any excess business holdings as defined in Section 4943(c) of the Internal Revenue Code; 4) shall not make any investments in such manner as to subject the corporation to tax under Section 4944 of the Internal Revenue Code; and 5) shall not make any taxable expenditures as defined in Section 4945(d) of the Internal Revenue Code.
5. Notwithstanding any other provision of these Articles, this corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

Having been named as registered agent to accept service of process for the above stated corporation at the place designated in this certificate, I am familiar with and accept the appointment as registered agent and agree to act in this capacity.
