ARTICLES OF INCORPORATION

We, the undersigned, hereby associate ourselves together for the purpose of becoming incorporated under the laws of the State of Florida, Florida Statutes 617, applicable to corporations not for profit.

ARTICLE I

The name of the corporation shall be Iglesia Bautista Libertad Incorporado (Biberty)

Baptist Church Incorporated).

ARTICLE II

Its principle place of business shall be 6255 Starhill Dr., Milton, Florida 32570. County of Santa Rosa, State of Florida.

ARTICLE III

The purposes for which this corporation is organized are exclusively religious, charitable, and educational within the meaning of Section 501 (c) (3) of the Internal Revenue code of 1986 (or the corresponding provision of any future United States Revenue Law), including, but not limited to, for such purposes, the establishing and maintaining of religious worship; and the building and operating of churches, parsonages, schools, chapels, radio stations, television stations, rescue missions, printing ministries, day-care centers, camps, missions boards, and nursing homes and any necessary projects needed to enhance this corporation.

ARTICLE IV

The corporation shall have members. The board of directors shall manage the affairs of the corporation. The number of the directors shall be fixed by the bylaws of the corporation, but may not be less than three (3). Directors shall be elected at the first meeting during the first quarter of each year.

ARTICLE VIII

The period of duration of the corporation is perpetual. In the event of dissolution of the corporation, the board of directors shall, after paying or making provision for payment of all the liabilities of the corporation, transfer all assets to a fund, foundation, organization which is organized and operated exclusively for charitable, religious, or educational purposes and at that time qualifies as an organization exempt from federal income taxation under Section 501 (c) (3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).

ARTICLE IX

No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the tax-exempt purposes of the corporation set forth in Article III.

ARTICLE X

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

ARTICLE XI

The corporation shall have a racially nondiscriminatory policy and therefore shall not discriminate against applicants, students, employees, and others on the basis of race, color, or national or ethnic origin.

ARTICLE XII

Notwithstanding any other provisions of these Articles, the corporation shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law) or by an organization, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).
