ARTICLES OF INCORPORATION

The incorporator, for the purpose of forming a corporation pursuant to chapter 617, Florida Statutes, the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation shall be Hospitality Educational Resources, Inc.
