ARTICLES OF INCORPORATION OF PENIEL EVANGELICAL ALLIANCE CHURCH, INC. OF DELRAY

WE, the undersigned, here by associate ourselves for the purpose of becoming a non-profit corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida providing for the information, liability, rights, priviléges and immunities of a corporation not for profit.

ARTICLE I Name of Corporation

The name of this corporation is Peniel Evangelical Alliance Church, Inc. of Delray.

ARTICLE II Purpose

The purpose of the corporation is to establish and maintain a regular church, cooperating with the missionary program of the church, and to provide a place of public worship for the same in the City of Delray Beach, County of Palm Beach, and State of Florida.

To establish, maintain and conduct schools for religious instruction, mission churches, mission stations, and to further other religious, educational and charitable work to that end, adopt and establish by-laws and make all rules and regulations deemed necessary and expedient for the management of its affairs in accordance with the law and not inconsistent with these Articles of Incorporation;

The manner of admission to membership shall be by acceptance by this church from other churches of like faith, being baptized in this church and as herein before provided upon a favorable majority vote of the membership of said church corporation present at any meeting of the church.

ARTICLE IX

Amendment
