



**ARTICLES OF INCORPORATION  
OF

- ONE:** The Name and address of this principal corporation J. L. Williams Ministries, Inc., 11330 NW 18th Street, Plantation, Florida 33323. The corporation is organized pursuant to FLORIDA Nonprofit Corporation Code.
- TWO:** This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for charitable and education purposes to aid individuals and families towards a life of self-sufficiency. The programs will consist of, but shall not be limited: Youth Education Development, Counseling, Early Childhood Development, Tutorial Program, Computer Literacy, Study Center, Youth and Senior Community Enrichment, Youth at High Risk.
- THREE:** The duration of this corporation shall be perpetual, no stock and shall have no members.
- FOUR:** The address of the REGISTERED office is 11330 NW 18th Street, Plantation, Florida 33323 and the name of the registered agent of the corporation shall be:

- FIVE:**
- (a)** This corporation is organized and operated exclusively for Educational and Charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.
- (b)** Notwithstanding any other provisions of these Articles, the corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code.

**SIX:** The Directors are elected in accordance with the Bylaws. The name and address of the persons appointed to act as the initial Directors of the corporation are:



**EIGHT:** On the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment of, all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation or corporation, which is organized and operated exclusively for Religious, Charitable and Educational purposes under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
