The undersigned in accordance with the provisions of Chapter 617, Florida Statutes, hereby make, subscribe and acknowledge these Articles of Incorporation.

**ARTICLE ONE – NAME OF CORPORATION**

The name of the corporation shall be: NEW LIFE IN CHRIST CHURCH, INC.  
effective September 5, 2001.

**ARTICLE TWO - PRINCIPLE OFFICE**

The principle place of business shall be: 12555 NW 17<sup>th</sup> Avenue, Miami, Florida 33167. The mailing address shall be: P.O. Box 562063, Miami, Florida 33256

**ARTICLE THREE - PURPOSES**

The purpose for which this corporation is organized as a non-profit corporation in accordance with the provisions of Chapter 617, under the Florida Not for Profit Corporation Act, is to operate a church, an organization that will train and equip people to advance the cause of Christ through ministries that educate, edify and evangelize.

**ARTICLE FOUR – ELECTION OF OFFICERS**

The primary officer shall be the Pastor. The Pastor shall be considered the spiritual overseer of the church, leading the church to function as a New Testament church and coordinating all of its activities. He shall be the registered agent of the corporation and shall act as chairman of all business meetings of the church and the church Council. He shall be an ex-officio member of all committees and departments. He shall arrange for all services of the church and shall coordinate all special meetings, conventions or revival campaigns.

Both the Pastor and other officers shall be elected in a meeting called for the purpose of an election by seventy-five percent (75%) majority vote, provided, however, that fifty percent (50%) of the active, voting membership of the church is present.

## **ARTICLE FIVE – INITIAL OFFICERS**

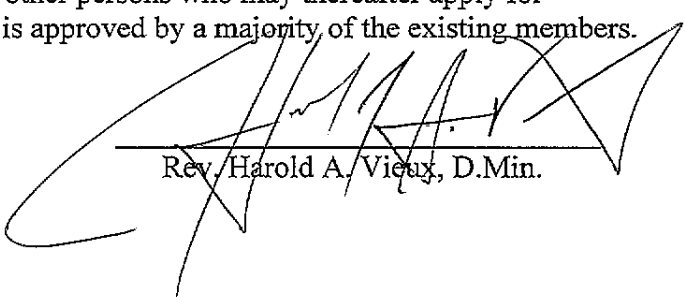

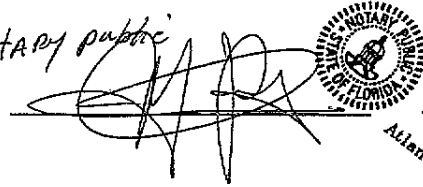

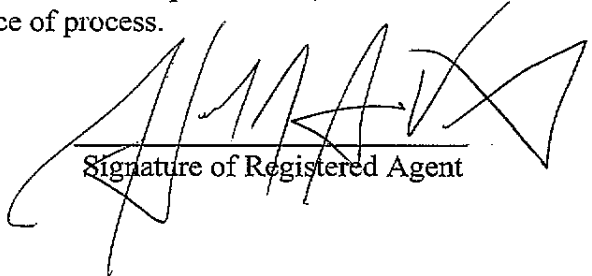
