to

#### ARTICLES OF INCORPORATION

Pursuant to the provisions of section 617.1001, Florida Statutes, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: Article III of the Articles of Incorporation of the Corporation shall be replaced in its entirety and the following shall be substituted in lieu thereof:

# ARTICLE III PURPOSE AND POWERS

The purposes for which this Corporation are organized are exclusively charitable, religious, educational and/or scientific within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding provisions of any future United States Internal Revenue Laws, including, but not limited to conducting programs for developmentally disadvantaged children. In general, the Corporation may exercise any powers for which a not-for-profit corporation, under the Florida Not-For-Profit Corporation Act, can be authorized to exercise.

SECOND:	The date of adoption of the Amendment was: 10/10, 2005.
