# **ARTICLES OF INCORPORATION**

In Compliance with Chapter 617, F.S., (Not for Profit)

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes for Not-For-Profit Corporations, adopts the following Articles of Incorporation.

## **ARTICLE I – NAME**

The name of the corporation shall be:

All God's Children NonDenominational Bible Temple, Incorporated

## **ARTICLE II – PRINCIPAL OFFICE**

The principal place of business and the mailing address of this corporation shall be:

## **ARTICLE III – PUPROSE**

This corporation is organized as a church exclusively for religious, charitable, and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue law), including, but not limited to, for such purposes, the establishing and maintaining of religious worship, the building of churches, parsonages, schools, chapels, radio stations, television stations, day-care centers, and camps; the evangelizing of the unsaved by the proclaiming of the Gospel of the Lord Jesus Christ; the educating of believers in a manner consistent with the requirements of Holy Scripture, both in Sunday and weekday schools of Christian education; and the maintaining of missionary activities in the United States and any foreign country.

## **ARTICLE IV – MANNER OF ELECTION OF DIRECTORS**

The affairs of the corporation shall be managed by the Board of Directors. The Pastor shall serve as the President of this corporation. All other directors of this corporation shall be appointed by the Pastor of the church, subject to a confirmation vote of the church membership. The number of the directors shall be fixed by the bylaws of the corporation, but may not be less than three (3).

#### **ARTICLE V – INITIAL DIRECTORS/OFFICERS**

The initial Board of Directors to hold office until the Pastor appoints new Directors shall be the Incorporators listed in Article VII of this document.

#### **ARTICLE VIII – PRIVATE INUREMENT**

No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the tax-exempt purposes of the corporation set forth in Article III.

#### **ARTICLE IX – POLITICAL INVOLVEMENT**

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

#### **ARTICLE X – RACIAL NONDISCRIMINATION**

The corporation shall have a racially nondiscriminatory policy and therefore shall not discriminate against applicants, students, employees, and others on the basis of race, color, or national or ethnic origin.

#### **ARTICLE XI – DISSOLUTION**

Upon the dissolution of the corporation, the board of directors shall, after paying or making provision for payment of all the liabilities of the corporation, transfer all assets to a fund, foundation, or organization which is organized and operated exclusively for charitable, religious, or educational purposes and at that time qualifies as an organization exempt from federal income taxation under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law) or by an organization, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).

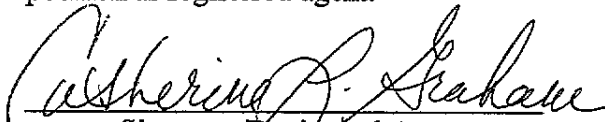
