Articles of Incorporation

OISEP 24 PM 1:32 The undersigned, acting as Incorporator for the purpose of forming a not for pro Corporation pursuant to Chapter 617 of the Florida Statutes, adopt the following Articles of Incorporation:

Article I

Name

The name of the corporation shall be:

American Disaster Relief Fund, Inc.

Article II

Principal place of business and mailing address

The principal place of business and mailing address of this corporation shall be:

Article III

Purposes

The specific purposes for which the corporation is organized are:

- To receive and administer funds and to operate exclusively for charitable Α. purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code of 1986, or comparable provisions of subsequent legislation, and to give funds to other organizations to be used or held for use directly for carrying out one or more of such purposes;
- To do such things and to perform such acts as accomplish its purposes as В. the Board of Directors may determine to be appropriate and as are not forbidden by Section 501 (c) (3) of the Internal Revenue Code of 1986, or comparable provisions of subsequent legislation, with all of the powers conferred on not-for-profit corporations under the laws of the State of Florida.
- Funds received by this corporation will be solely for distribution, at the C. appropriate time and through the appropriate channels, to victims and families of the September 11, 2001 terrorist attack in the United States.
