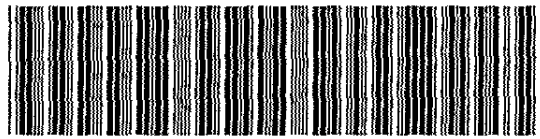

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

FIRST: Amendment(s) adopted: (INDICATE ARTICLE NUMBER(S) BEING AMENDED, ADDED OR DELETED.)

Pursuant to Section 617.1006 of the Florida Statutes the above named corporation is amending its Article Number III including the name of the seminary entity provided by Lifestream Prayer Praise and Bible Study Ministries, Inc., and adding Article Number XI, Article Number XII, Article Number XIII, and Article Number XIV to its Articles of Incorporation.

ARTICLE #III: PURPOSE

The purpose for which the corporation is organized is: exclusively for charitable, benevolent, educational purposes -- including LPMI Home Bible Institute and School of Theology - Christian education of children, adolescents and young adults, academic assistance, scientific and other religious functions within the meaning of section 501(c)3 of the Internal Revenue Code of 1986 or corresponding provision of any future U.S. I.R.S. Law. The name will be changed from LPMI Christian Academy and Theological Seminary to LPMI Theological Seminary and Bible Institute-an entity of Lifestream Prayer Praise and Bible Study Ministries, Inc.

ARTICLE XI: ENTITLEMENT TO AWARD DIPLOMAS CERTIFICATES AND DEGREES

The Theological Seminary and Bible Institute of Lifestream Prayer Praise and Bible Study Ministries may award and/or bestow certificates, diplomas and degrees (to include honorary) upon candidates who successfully meet and complete all classes, exams and educational requirements in the Bylaws, Article III, Section 2 (A) and (B) of the corporation mission statement.
