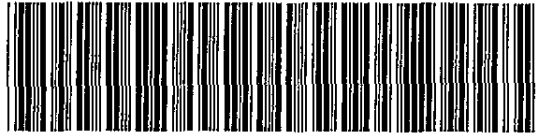

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

FIRST: Amendment(s) adopted: (INDICATE ARTICLE NUMBER(S) BEING AMENDED, ADDED OR DELETED.)

Pursuant to Section 617.1006 of the Florida Statutes the above named corporation is amending its Article Number III including the name of the seminary entity provided by Lifestream Prayer Praise and Bible Study Ministries, Inc., and adding Article Number XV, and XVI to its Articles of Incorporation.

**ARTICLE #XV: NON-TRADITIONAL HOME SCHOOL CORRESPONDENCE
EDUCATIONAL APPROACH: AVERY INSTITUTE**

Also known as A.S.H.-S.C.A.I. This Article has been adopted by the Board of Directors of LPMI and is hereafter added as an extension school of Lifestream Prayer Praise and Bible Study Ministries Inc. for the purpose of creating educational opportunities for secondary students, ages 11-20, and adult basic education; for at risk individuals, high school drop-outs, alternative choice; GED training, vocation and career skill training and job preparation; ESOL education and Exceptional student education; in a non-traditional format. Offered as a distance learning - home school correspondence program supported by parents, family, church, and other remedial and community sponsors.

The program requires 24 successfully completed credits with a passing grade of 80% or above for high school diploma and 78% or above for GED; ESOL and other disciplines (subject to change). Students may participate in all standard services afforded to LPMI Christian Academy and LPMI Bible Institute to include, but not limited to, graduation, scholarships, tuition and other services as approved by the Board of Directors, Administration and Faculty of LPMI.

The option of an onsite campus will be available according to student enrollment (to be determined by funding and annual success evaluations). Avery Institute is established as a private, non-profit secondary and vocational training school.

ARTICLE XVI: TRANSFER OF OWNERSHIP OF CORPORATION

In the event of the death of or incapacitation of Pazaria Smith, President and Founder of Lifestream Prayer Praise and Bible Study Ministries, Inc. and its subsidiary entities, to include LPMI Christian Academy, LPMI Theological Seminary and Bible Institute, Moe's Moving and More, and Avery Institute, the corporate executive office, administration and ownership of the corporation will be filled by Karla L. Henry, who will have all privileges, rights, and authority to conduct the business of the corporation, make changes as deemed necessary and replace officers, staff and Board of Directors at her discretion. The operation of the corporation will be shared with Kaffie M. Bradley-Henry, and Khiry K. Smith (when he becomes of age). All final decisions will be made by the President, Karla L. Henry.
