ARTICLES OF INCORPORATION

Articles of Incorporation of One World United To Save the Humans, Incorporated, a non-profit charitable organization. The undersigned Incorporator and Officers of the Corporation, a majority of whom are United States Citizens, desiring to form a Non-Profit Corporation under the Florida Not For Profit Corporation Act and under all applicable US Laws, do hereby adopt the following Articles of Incorporation:

First: The name of the corporation shall be: One World United To Save the Humans, Incorporated.

Second: The place in the State of Florida where the principal office of the Corporation is to be located is the City of Pensacola, the County of Escambia, Florida. Mailing address is: 38 South Blue Angel Parkway, #343, Pensacola, Florida, 32506.

Third: Said corporation is organized exclusively for charitable, educational, public safety, and scientific purposes, including, for such purposes, the solicitation, collection and making of distributions to One World Inc. and other organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Said corporation is organized for the following stated purposes:

THE PURPOSES OF ONE WORLD UNITED TO SAVE THE HUMANS, INC. (A Non-Profit Charity)

ARE SET FORTH AS FOLLOWS:

Mission Statement:

To empower and enable common citizens around the world to collectively address and eliminate all threats to the survival of the human race. "To save the Humans."

1. **Global Population Control:** To promote and encourage birth control options around the world, and to educate people in all countries that if we do not gain control over world population growth, we will not survive as a species. To distribute birth control pills and devices, along with assisting and providing in medical care as required, all such to be free of charge to the recipients, as needed to accomplish this goal, to include but not be limited to accomplishing a massive reduction in world wide human population growth; along with any and all other activities required to achieve these goals. To assist all other existing legitimate charities such as the United Nations World Population Fund, etc., to be selected from time to time by One World United,

Inc., who share this same goal as much as possible. To further include but not be limited to any and all other activities necessary to accomplish these goals.

2. Feed the World: To do everything in our power to stop, permanently eliminate and prevent: hunger, malnutrition, poverty, war and disease worldwide, to include but not be limited to providing medical care, medicine, food, goods, equipment and services, relocation, travel and transportation of peoples who so request such aid, all to be free of charge of any kind to the recipients, to engage in the training, education, hiring and compensation of any and all personnel as may be needed to accomplish these goals and any and all other activities required in order to accomplish these goals along with the support of all other existing legitimate charities such as the United Nations World Food Programme, and others who may be chosen from time to time at the sole discretion of One World United, Inc., who share these goals. To include but not be limited to any and all other activities necessary to accomplish these goals.

3. Save the Earth: To stop the destruction of the natural environment of this planet. This includes all activities legally allowable under existing FCR and US Code, but is not limited to, stopping: pollution world wide, global warming, the loss of any and all living creatures as a species who share our planet and the habitats of said creatures, the loss of flora and fauna, contamination of our water resources, air pollution, environments dangerous to human beings and other living things, the logging of ancient forests, the detonation of any and all types of nuclear bombs/warheads, etc. anywhere on our planet along with any type of chemical and bio-terrorism device, in addition to stopping the development and testing of any and all such devices anywhere in the world, the destruction of our soil, the pollution, destruction, and devastation to our oceans to include all creatures who inhabit our oceans, including but not limited to the collection, distribution and publication all information gathered regarding the above throughout the world through a variety of mass media outlets with the express goal of providing an information data base readily and easily available to the public, for instance Global warming has had the unanticipated result of raising the temperature of certain ocean currents which could swiftly result in the sudden release of recently discovered reservoirs containing billions of gallons of methane gas in the ocean floor; just one warm ocean current producing the sudden release of said reservoirs could result in rapidly raising the temperature of the planet by more than 12 degrees Fahrenheit, a catastrophic E.L.E. (Extinction Level Event.) Global warming and/or "the Greenhouse Effect" has previously been considered by all scientific communities to be a threat to which we had close to one hundred years to address. To include but not be limited to any and all other activities which may be required in order to accomplish these goals.

4. President Kennedy's Volunteers: To organise, fund, promote and supervise major televised media events recruiting individuals into active humanitarian service to further accomplish the goals set out above and below, and those of One World United, Inc., to solicit and collect donations for the same purposes, to include but not be limited to award ceremonies recognising service under this program, to include but not be limited to deliberate memorials following the leadership and speeches one of the greatest civil rights and humanitarian leaders of the twentieth Century President John Kennedy, to further include but not be limited to Senator Robert Kennedy, and the charitable examples previously established by John F. Kennedy Jr., along with other members of their family and other leaders chosen from time to time by One World such as

Martin Luther King Jr. and others from all of human history, (be it hereby noted the Founder is not affiliated with any existing political party,) but with emphasis on the four above as lifelong heroes of the Founder, to include but not be limited to the awarding of college scholarships, the awarding of financial grants, and the awarding of trophies, certificates, ribbons, badges and etc. to those who have distinguished themselves through service and contributions, and to further include but not be limited to weekly, monthly, and/or annual television productions about same, and to feature length films about the same. To further include but not be limited to any and all other activities which may be needed to accomplish these goals.

In keeping with the above stated goals the official mottoes of One World United Inc. hereby adopted are:

"We came not to curse the darkness, but to light a candle." President John F. Kennedy

"Some men see things as they are and ask why. I see things that never were, and ask, why not?" Senator Robert F. Kennedy

"Alone we can do so little. Together we can do so much." Helen Keller

"If we stay together, we survive." Actor Russell Crowe as the General Maximus from the film Gladiator.

5. Sutter's Victory Gardens: To establish agrarian community farms constructed after the Israeli "kibbutz" model utilizing donated government lands and/or any and all other lands which can be acquired for the same purpose with the goal of becoming self-supporting, self-sufficient communities in order to offer an alternative lifestyle and escape from poverty to those who choose to volunteer to live in these community farms and who meet the criteria as established by One World United, Inc., and whose additional purposes include but are not limited to teaching environmentally protective farming and irrigation techniques with the goal of these community farms not only being a place of permanent residence for its inhabitants but also offering instruction to temporary inhabitants with a primary emphasis on environmentally protective agricultural and animal husbandry techniques, and removing salt deposits and other pollutants contaminating soils on a worldwide basis, in an effort to prevent the current ongoing massive loss of useable soils which if not stopped will produce worldwide famine. Currently only 29% of CONUS useable soil is free of said contamination, 13% uncontaminated soil left in Australia, less than 6% left in Asia, China, and Africa, and less than 9% left in Europe. These facts indicate to the Founder that a massive worldwide famine may be imminent within ten years or less. As such said community farms are to also create, establish and maintain a program of community and family gardens similar to the Victory Gardens of World War II, programs of nature conservancy to include but not be limited to both domestic and wildlife animal husbandry and rescue, and further promoting said ecologically sound agrarian techniques and implementing a food storage program. This program is designed especially to offer a way out of the cruel level of poverty which often exists in inner city ghettos, dangerous environments, third world countries, and others who for whatever reasons have become disenfranchised, homeless, and disadvantaged,

and further to be a measure of citizen originated civil defence against the collapse or destruction of the food distribution infrastructure from whatever cause. Said communities are to be established on a community by community basis. This particular subsection of said corporation is to honour the memory of John August Sutter of California Gold Rush fame, who lost a 50,000 acre estate and working farm, (his ownership of which and clear title to was awarded and properly adjudicated by the State of California and the United States Supreme Court) due to the greed and avarice of his fellow citizens and a breach of duty upon the part of the United States Government and the State of California through their failure to protect Sutter's property from the onslaught of the Gold Miners, and as such shall be named after John August Sutter, of whom the Vice President John Sutter Butsch of said Corporation is a descendant. John Sutter's Family both immediate and extended along with its heirs should to this day be among the wealthiest families in the United States save for this grave injustice, which is perhaps the grossest injustice and largest loss of property and wealth to a single individual and his family in all of American history, especially upon consideration of the facts that all of the gold (and the subsequent fortunes built from it) discovered on this 50,000 acre estate to include all benefits which should have enured from ownership of same, (said area which now comprises the city of Sacramento and its environs along with the entire Silicon Valley and beyond,) belonged by all rights to John Sutter and his family and heirs. Except for this gross, grave injustice those lands and all which they have produced over the last one hundred and sixty years should have belonged to the Sutter family. To include but not be limited to any and all other activities which may be required in order to accomplish these goals.

6. **John F. Kennedy Jr.'s The Heroes of Tomorrow:** The establishment, funding, building, and implementing (but not limited to) of an educational history program along the lines of a permanent "summer" camp which recreates certain events as realistic dramas and "living re-enactments" in which students from all over the world and all others can actively participate in and experience various heroic episodes in world history at no cost to them, from World War II to all other wars around the world for the simple purpose of educating our younger generations about the sacrifice and high price paid for freedom, highlighting specifically heroes and acts of heroism, bravery and self-sacrifice, with a special emphasis on ending racism and bigotry, elevating human rights and the human dignity of all, and to increase cultural understanding, by offering dramatic and "live theatre" experiences designed to change perspectives in keeping with the creed that "We are all the same," to include but not be limited to eventually purchasing and creating a permanent physical location and constructing facilities in which this historical educational program can be taught and implemented, in concert with a literature program focusing on the literature and poetry of bravery, patriotism, courage, compassion and leadership, said program which shall be dedicated to the memory of **Jacqueline Kennedy Onassis** to include but not be limited to any and all other activities which may be required in order to accomplish these goals.

7. **The Watchdog of Weapons of Mass Destruction:** To create, establish and implement a citizens watchdog group which locates and identifies through whatever legal resources and avenues needed and available the number of all existing nuclear bombs, warheads, and any and other all such devices of war and global destruction, to encourage, promote and accomplish the destruction of all such devices by voicing opinions, etc., including but not limited

to vocalizing demands for total permanent bans on research and development of such devices throughout the world, to include but not be limited to any and all weapons and/or devices biological and chemical in nature, including but not limited to bio-terrorism bombs and devices, to include but not be limited to locating, identifying and removing land mines around the world, to promote and encourage world wide bans eliminating the ongoing and future creation of any and all such devices, and the testing of any and all such devices, and to publicize any and all such information gathered on a world wide basis on a scale as massive as possible, to promote, encourage and solicit creation of a citizen's data information base through a variety of media and support groups in all countries drafted to accomplish these goals and the necessary support for same through any legal means and/or activities available as defined under US Code, along with gathering donations, volunteers, etc., to include but not limited to any and all other activities required to accomplish these goals.

8. President Kennedy's Space Colony. To create, build, organize and construct human colonies on the Moon, and on any other viable location not on planet Earth, in the event that this charity fails in its stated goal to forever rid the world of all weapons of mass destruction and stop all research and development of the same, which the Founder fears may never happen until such time as a global thermonuclear war occurs, and/or the release of biological and chemical agents annihilate the bulk of the human beings on this planet. To include but not be limited to hiring all personnel necessary to accomplish these goals, soliciting and gathering donations and volunteers to fund and accomplish these same goals, to construct shelters and colonies also on the Earth, all said such colonies and shelters to be designed and constructed with the express purpose of insuring both the present and future survival of the human race as a species. This charity seeks to work in concert and to contribute directly to all existing government space programs with an active program to accomplish same said goals but is hereby specifically restricted only to those governments with a treaty with the United States of America and further subject to the approval of the United States of America's Department of State. The Founder believes that if a farsighted thinker had established a charity with similar goals when Jules Verne first published the idea of sending a rocket to the Moon and had succeeded in obtaining the support of a few very wealthy philanthropists there would today exist a multi-trillion dollar fund to aid and support N.A.S.A. in accomplishing this feat, which would in no way be subjected to the numerous social and political difficulties N.A.S.A. has experienced in its efforts to obtain funding for its various programs. To include but not be limited to any and all other activities which may be necessary to accomplish these goals.

9. Helping Hands. To aid and assist through a wide variety of methods, activities and measures all other existing legitimate charities as selected by One World United, Inc., to include but not be limited to all other charities which share the same goals as One World for the purposes of efficiency, expediency, and eliminating duplication of effort, such as the United Nations World Population Fund, the United Nations World Food Programme, Save the Children, World Wildlife Fund, VOA, Meals On Wheels and other comparable existing legitimate charities in the US and all over the world which may be chosen from time to time by the sole discretion of One World United To Save the Humans, Inc., to include but not be limited to distributing donations made to One World United, Inc. to these other chosen charities, and assigning volunteers who have volunteered to One World United, Inc., in addition but not limited to any and all other activities as

required in order to accomplish these goals, while reserving any and all rights to extend, revise and/or expand these goals as desired at any point in time.

10. **Senator Edward and Robert Kennedy's Angels of Mercy:** To create, establish and implement a citizen's consumer advocate group to whom citizens of all countries can file complaints and receive assistance from, regarding their experiences with various government bureaucracies, programs and institutions, worldwide, and to publish all information gathered, to particularly act as an information clearing house in order to facilitate communication between governments and their citizens regarding all available programs, to act as a liaison and facilitator to connect people with needs to the correct and proper available government programs and community resources, the specific goal being to catch the citizens who currently fall through the "cracks" of existing government sponsored aid programs, to render assistance of any kind as needed to such people during the interim period while they are waiting to become qualified for said programs, such as cancer patients waiting on an award of Medicare and/or Medicaid benefits who no longer have the luxury of time, who in many cases lay dying while they await to qualify for such aid programs and/or who have already been denied and can gain approval only through the appeal process and the great length of time (time which dying citizens can no longer afford) the appeals process takes before qualification for said aid programs is approved, (and all other comparable programs in other countries). The Founder recently took a poll of 50 local college freshmen and not *one* had ever heard of the V.I.S.T.A. program. To include but not be limited to any and all other activities as may be required in order to accomplish these goals.

11. Said Corporation is further organized by vesting the Chair of the Board with a permanent 55% vote in the Board of Directors with a further stipulation that if Chair is ever removed for any reason from that Office her replacement will be designated by Chair and quorum vote of the Board of the Directors or said Corporation will be dissolved in accordance with applicable law and statute within meaning of IRS 501(c)(3).

12. **Sky Watchers:** Said Corporation is further organized to establish and implement an astronomical watchdog program to detect incoming heavenly bodies such as asteroids and meteors, etc., which may impact the Earth to an extent which may threaten the survival of the human race as a species and the survival of the planet itself as a viable ecosystem, to further aid any and all other such programs in existence with this same goal of detection of such threats as may be chosen at the sole discretion of One World United To Save the Humans, Inc., and to further create and establish a defense to this threat, to include but not be limited to the establishment and construction of human colonies and "arks" within shelters both on this planet and in any other viable location other than this planet, to enable and insure that our grandchildren and their grandchildren will truly inherit not only life but also the Earth itself in all its bounty as a viable ecosystem and human habitat, and any other habitat which may be acquired. To include but not be limited to any and all other activities as may be necessary to accomplish these goals.

13. **Citizens Against Terrorists :** Said corporation is further organized to provide a massive public data base publicized on a world wide basis to provide information to common people all over the world on known terrorists groups, activities, and their members to a high degree of efficiency in order to enable common people everywhere to recognise known terrorists

and to report suspicious activities to a toll-free hotline to be reported to the appropriate government and law enforcement agencies so that the terrorist attack on the United States of America on September 11, 2001 may never happen again here or anywhere else in the world. To further include but not be limited to any and all other activities necessary to accomplish these goals.

14. The foregoing purposes, goals and activities will be interpreted as examples only and not as limitations, and nothing herein shall be deemed as prohibiting the corporation from extending its activities to any related and/or otherwise permissible lawful business and charitable purposes which may become necessary, beneficial, profitable or desirable for the furtherance of the corporate charitable objectives stated above.

Fourth: The manner in which the current Directors and Officers of One World United, Inc. were selected was through appointment by the Incorporator, Founder, and Chair of the Board. All future such Officers and Directors of said Corporation are to be appointed in the same manner, with a quorum vote affirming such appointments from the Board of Directors.






Sixth: No part of the net earnings of said Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or, notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of said Corporation.

Seventh: Upon the dissolution of said Corporation, assets shall be distributed to a new non-profit charity corporation to be organised solely by the Chair of the Board, or for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal offices of the corporation is then located, exclusively for such purposes or to such organisation or organisations, as said Court shall determine, which are organised and operated exclusively for such purposes.
