Letter of Resignation

Greetings in the precious name of Jesus:
January 22, 2002

Dear Pastor Stiver,

This letter is written to first express my sincere love and appreciation to you for allowing me to partake of your vision for the school – Ambassadors Christian Life Academy, Inc. I trust in some small way, I have made some kind of significant impact in your ministry. As of this date, I am rescinding my position as Principal and Agent of Ambassadors Christian Life Academy, Inc.

I am still willing to make revisions in your handbook if you want me to do so. I will also remit all materials belonging to Ambassadors Christian Life Academy including: credit cards for Office Depot, Staples, all materials purchased, stamps, Xerox paper (unused), handbooks, receipt book, employment applications, all miscellaneous papers, etc. to Pastor Bobbie L. Stiver, in person. I will also submit the Book of Articles of Incorporation and By-Laws, membership certificate for ACSI (Association for Christian Schools International), receipts from Office Depot depicting full payment for HP Office Jet K80 copier/printer, paid for by Pazaria Smith-Mobley in the amount of \$400. I did not reimburse myself for any other money spent for such things as: room dividers in the amount of \$312, the opening of the school bank account in the amount of \$100, and other money spent in regard to ACLA.

Let it be noted that Pastor Bobbie L. Stiver has in her possession the bankbook and deposit slips for said corporation. It is further noted that Pazaria Smith-Mobley has never been a signer on this account, and that her name will be removed as a signer on the said bank account for Ambassadors Christian Life Academy as of Tuesday, January 22, 2002.

All corrections related to the school where Pazaria Smith-Mobley is involved will be voided and corrected: Post Office Box number from P.O. Box 1184, Sanford, FL 32772 to Pastor Bobbie L. Stiver at P.O. Box 1553 Sanford, FL 32772; all correspondence – letters, books, invoices, etc. In addition, please consider the amount of time spent from August through October 2001 in instruction of a seminary class held at Ambassadors for Christ Church, where Bobbie L. Stiver is Pastor, as a gift. There were approximately four people that paid a fraction of the cost of \$125, which was considered less than the amount charged for services of this nature.
