ARTICLES OF INCORPORATION  
OF

In accordance with Chapter 617, Florida Statutes, the undersigned, acting as incorporator of a corporation under the Florida Not For Profit Corporation Act, hereby adopts the following Articles of Incorporation for such Corporation:

ARTICLE I  
Name of Corporation

The name of this corporation shall be DOORS OF HOPE FOUNDATION, INC. The principal office and mailing address of this corporation is 3500 Fairlane Farms Road, Suite 12, Wellington, Florida 33414.

ARTICLE II  
Purposes

This Corporation is organized for the transaction of any and all lawful business, the purpose of which is exclusively charitable or educational within the meaning of Section 501 of the Internal Revenue Code of 1986.

ARTICLE III  
Prohibited Activities

No part of the net earnings of this Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that this Corporation shall be authorized and empowered to pay any reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article II hereof.

No substantial part of the activities of this Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and this Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of these Articles, this Corporation shall not carry on any other activities not permitted to be carried on by (a) a corporation except from Federal income tax under Section 501 of the Internal Revenue Code of 1986, or the corresponding provisions of any future United States Internal Revenue Law or (b) a corporation the contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986, or any other corresponding provisions of any future United States Internal Revenue Law.

ARTICLE IV  
Membership

There shall be two classes of members of the Corporation: Voting Members and Non-Voting Members. There shall at all times be at least one Voting member. There shall always be an odd number of Voting Members, and there shall always be an odd number of Non-Voting members. The sole initial Voting Member shall be MARGARITA R. KAHN. The initial Non-Voting Member shall be RAYMOND KAHN. The number, qualification, and manner of admission of members shall otherwise be as provided in the Bylaws.

There shall be a Chairman of the members which shall, except as otherwise provided herein, be elected by a majority of all Voting Members. The initial Chairman of the members shall be MARGARITA R. KAHN.

At such time as MARGARITA R. KAHN is no longer a Voting Member, unless there are other Voting Members, the initial Non-Voting Members named in these Articles of Incorporation, or such of them as are then members, shall become the Voting Members.

ARTICLE V  
Initial Registered Office and Agent

The street address of the initial registered office of this corporation is 3500 Fairlane Farms Road, Suite 12, Wellington, Florida 33414 and the name of the initial registered agent of this Corporation at such address is Margarita Kahn.

ARTICLE VI  
Board of Trustees

Section 1. Number. This Corporation shall have three (3) Trustees initially. The number of Trustees may be either increased or diminished from time to time in accordance with the Bylaws, but shall never be less than three (3), nor more than fifteen (15). The Trustees shall be members.

Section 2. Initial Board. The names and addresses of the Initial Trustees of this Corporation, who shall serve until their successors are elected or appointed and have qualified, are:

Section 3. Election and Removal. Trustees shall be elected and may be removed with or without cause, notice, or hearing only

by the affirmative vote of a majority of all Voting Members.

ARTICLE VII  
Dissolution

Upon the dissolution of the Corporation, any assets shall be distributed for one or more exempt purpose or purposes specified in Section 501 of the Internal Revenue Code of 1986, or corresponding sections of any future federal tax code, or to the federal, or a state, or local government for exclusive public purposes.

ARTICLE VIII  
Bylaws

The By-Laws of this Corporation shall be adopted, altered, amended or rescinded at any regular or special meeting of the members of this Corporation by the affirmative vote of a majority of all of the Voting members of the Corporation.

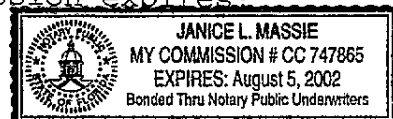
