

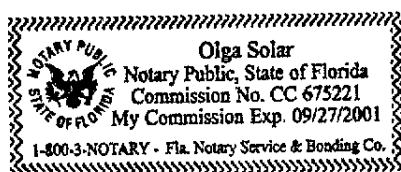




ACCEPTANCE OF REGISTERED AGENT
