ATTACHMENT TO ARTICLES OF AMENDMENTS TO ARTICLES OF INCORPORATION OF IGLESIA CRISTO ES LA VICTORIA, INC. N01000006959

Article 111 being amended to read as follow:

This church is a nonprofit ecclesiastical corporation organized and operated exclusively for religious purposes within the meaning of Section 501(c)(3) of the United States Internal Revenue Code of 1986, as amended (or the corresponding provision of any future United States Internal Revenue law (Code). The church shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Code or (b) by a corporation contributions to which are deductible under Section 170 (c) (2) of the Code. This church has not been formed for pecuniary profit or gain. No parts of the assets, income, or profits of the church shall insure to the benefit of its members, council members, trustees, or officers or to any individual.

The purpose of this church shall be to maintain and preserve the spiritual and physical well-being and unity of its members and to visibly share Christ's life, forgiveness and salvation among ourselves and in our community and in the World by the regular preaching of the Word of God and Holy Sacraments.

Article V11 being added to read as follow:

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal offices of the organization is then located, exclusively for such purposes.
