Articles of Incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify the following Articles:

ARTICLE I - CHURCH NAME

The corporate name of this Church, a Non-Profit Corporation shall be *Outreach Christian Fellowship, Inc.*

ARTICLE II - PRINCIPAL OFFICE

The principal location and mailing address of this corporation shall be: 700 N.W. 57th Avenue; Ocala, Florida; Marion County.

ARTICLE III - THE PURPOSE OF THIS LOCAL CHURCH

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes; including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code. The specific purpose of *Outreach Christian Fellowship, Inc.* is to minister to lost souls who have no knowledge of JESUS, or His forgiving love for us all; and to also go out into drug infested areas and to express God's love for persons addicted to "crack" cocaine and other drugs; provide shelter for those who do not have a place to reside when they come off the street; and to build families by providing them with education and guidance in the Word of God.

ARTICLE IV - MANNER OF ELECTION

All officers, directors, or trustees are selected, appointed and elected as stated in Articles #7 and #8 of the Church By-Laws. Having been Educated, Licensed, Ordained and led as we believe by the Holy Spirit of God, we proclaim the Lord Jesus Christ as our Lord and Savior.
