**ARTICLES OF INCORPORATION OF  
PEER LINK SUPPORT SERVICES, INC.  
(A Florida Not-For-Profit Corporation)**

**ARTICLE I**

The name of this corporation is: Peer Link Support Services Inc. This corporation shall be organized as a not-for-profit corporation under the not-for-profit statutes of the State of Florida.

**ARTICLE II**

Said corporation is organized for charitable, educational and scientific purposes including for such purposes the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future tax code.

**ARTICLE III**

This not-for-profit corporation shall have perpetual existence and its corporate existence shall commence at the time of filing of these Articles of Incorporation with the Secretary of State.

**ARTICLE IV**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributed to, its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set fourth in Article II hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in, (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by (a) a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code

## ARTICLE VII

All members in good standing shall have the right to vote for the officers and the Board of Directors. Elections for membership to the Board shall be held annually, the date shall be determined at the first meeting of the Board of Directors. The by-laws shall proscribe the composition of the Board of Directors and the duties of the said officers.

## ARTICLE VIII

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Any such assets not disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is located shall be distributed to an organization that qualifies under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code, for such exempt purposes that most closely match the mission of this organization.

## ARTICLE IX

The Articles of Incorporation may be amended in the manner provided by law or as provided by the by-laws of the corporation. Every amendment shall be approved by the Board of Directors and approved by the majority of members who are entitled to vote.

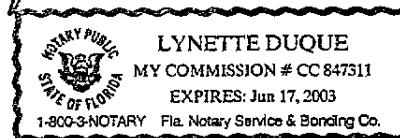
