## ARTICLES OF INCORPORATION OF BELLE EPOQUE CONDOMINIUM ASSOCIATION, INC.

In order to organize a Corporation Not For Profit under the laws of the State of Florida, the undersigned subscribers, LIA DURANGO, and ESTELA RUSSELL, hereby make, subscribe, acknowledge and file these Articles of Incorporation with the Department of State of the State of Florida.

- 2.
