ARTICLES OF INCORPORATION

OF

FONDO DE SAN JOSE, INC.

(NOT-FOR-PROFIT CORPORATION)

The undersigned, acting as incorporator(s) of a Corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation of such corporation:

ARTICLE I

The name of the corporation is: **FONDO DE SAN JOSE, INC.**

The principal place of business of this corporation shall be:
7809 W. Commercial Blvd., Tamarac, FL 33351

ARTICLE II

The period of the duration of this corporation shall be perpetual unless dissolved according to law.

ARTICLE III

The purpose for which this corporation is organized is: To assist the Catholic Church "DIOCESIS DE ISTMINA-CHOCO" in Colombia, to further its pastoral works in helping the needy without geographical limitations.

ARTICLE IV

- 2) Must have prior working or educational experience in the field of charitable organizations.

ARTICLE VI

This corporation is organized under a non-stock basis.

ARTICLE VII

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Section 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future law, or the Federal, State, or Local Government for exclusive public purpose. —

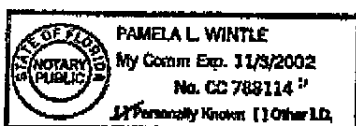




