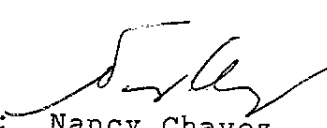

CORPORATE NAME: The name of the corporation shall be:

GABRIEL COMMUNICATIONS & MEDIA MINISTRY, INC.

ARTICLE II

NATURE OF CORPORATE BUSINESS: The corporation is a non-profit organization and may engage only in any activity related to:  
1.- The Production of Media Programs transmitting Spiritual Values.  
2.- Sharing of the Principles and Teachings of Jesus Christ and how to apply them to daily life. No part of its assets or income shall be distributable to or inures to the benefit of its members, trustees or officers or any private individual.
