**ARTICLES OF INCORPORATION  
FOR  
THE FREEDOM PROJECT, INC.**

**ARTICLE I. - NAME**

The name of the corporation shall be THE FREEDOM PROJECT, INC., a corporation not for profit.

**ARTICLE II. - PRINCIPAL OFFICE**

The principal place of business and mailing address of the corporation shall be 4901 W. Fairfield Drive, Pensacola, FL 32506.

**ARTICLE III. - PURPOSE**

The specific purpose for which the corporation is organized is to assist in ministry in county jails, correctional institutions, prisons and rehabilitation facilities in the state of Florida; to start a pilot prison ministry program to aid individuals currently or formerly incarcerated in correctional institutions as allowed by law in the state of Florida; and to conduct any and all lawful business or activities allowed by law to not-for-profit corporations.

**ARTICLE IV. - MANNER OF ELECTION OF DIRECTORS**

Directors of the corporation shall be appointed by Vicky R. Vaughan and shall serve a term of one year.
