TO
ARTICLES OF INCORPORATION
OF
THE FREEDOM PROJECT, INC.

FIRST: The following provisions of the Articles of Incorporation of The Freedom Project, Inc., a Florida corporation, filed in Tallahassee on October 1, 2001, by and they hereby are amended in the following particulars:

The following Articles are hereby amended, added, or renumbered to read as follows:

ARTICLE I - NAME

The name of the corporation shall be **FREEDOM IN JESUS CHRIST, INC.**

ARTICLE III-PURPOSE

The specific purpose for which the corporation is organized is to operate a church and to assist in ministry in county jails, correctional institutions, prisons and rehabilitation facilities in the State of florida; to start a pilot prison ministry program to aid individuals currently or formerly incarcerated in correctional institutions as allowed by law in the State of Florida; and to conduct any and all lawful business or activities allowed by law to not-for-profit corporations.

ARTICLE VI

This corporation is organized under a non-stock basis.

ARTICLE VII

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future law, or to the Federal, State or Local Government for exclusive public purpose.

ARTICLE VIII

The purposes for which the corporation is organized are exclusively religious, charitable, scientific, literary and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

ARTICLE IX

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

ARTICLE XI--INCORPORATOR

ARTICLE XII--EFFECTIVE DATE

The effective date of the corporation shall be the date of receipt of these Articles of Incorporation by the Department of State of Florida, and the effective date of the Amendments shall be the date adopted by the Board of Directors.


