The undersigned, acting as Incorporator for the purpose of forming a not for profit corporation under the Florida ~~Non-Profit~~ Corporation Act, hereby adopts the following Articles of Incorporation for such not for profit corporation.

### ARTICLE I

#### NAME AND PRINCIPAL BUSINESS LOCATION

The name of this Not for Profit Corporation shall be:

### ARTICLE II

#### DURATION

The period of the Not for Profit Corporation's duration is perpetual.

### ARTICLE III

#### PURPOSE

The purpose is to engage in not for profit educational and charitable activities under the laws of the United States and the State of Florida, including, but not limited to, the more specific function of, free help to any person in need (i.e. food, clothing, orientation, placement, enrollment in schooling or immigration papers, etc . . .).

The members of this Not for Profit Corporation reserve the right to amend or repeal, by majority vote, any provision contained in these Articles of Incorporation and/or By-Laws or any amendment hereto, and any right conferred upon the members is subject to this reservation.

## ARTICLE XI

### REVENUE

No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its Members, Directors, Officers, or other private persons. Except to the extent that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered, as well as, to make payments and distributions in furtherance of the purposes set forth in Article III hereof. The corporation shall not in any way, directly or indirectly, carry on propaganda or otherwise attempt to influence legislation, or participate or intervene in any political campaign on behalf of any candidate for public office, by publishing or distributing statements or otherwise. Notwithstanding any other provisions of these Articles, this not for profit corporation shall not carry on any activities not permitted to be carried on by either; (a) a corporation exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provisions of any future United States Internal Revenue Law), or (b) a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Revenue Law).

## ARTICLE XII

### DISSOLUTION

Upon the dissolution of the corporation, the Board of Directors shall pay or make provisions for the payment of all of the liabilities of the corporation. After the aforementioned is complete, the Board of Directors shall at their discretion, dispose of all of the remaining assets of the corporation (exclusively for the purposes of the corporation). The assets shall be disbursed in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law). Any such assets not so disposed of by the Board of Directors shall be disposed of by the Circuit Court, of the County in which the principal office of the corporation was located. All distributions shall be exclusively for, not for profit purposes and to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
