ARTICLES OF INCORPORATION

OF

NIGERIAN-AMERICAN FOUNDATION, INC.

The undersigned, incorporator, for the purpose of forming a corporation in compliance with Chapter 617 of the Florida Statutes, (Not for Profit) hereby adopts the following Articles of Incorporation:

ARTICLE 1: NAME

The name of the corporation shall be NIGERIAN-AMERICAN FOUNDATION, INC. hereinafter referred to as the "Corporation".

ARTICLE 11: PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 17847 NW 27th Avenue, Miami, Florida 33054.
