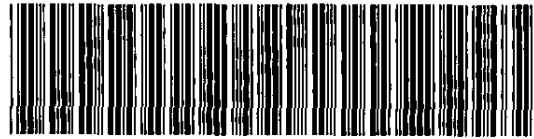



Pursuant to the provisions of 617.1006, Florida Statutes, the Boca Raton Bromeliad Society, Inc., a Florida Not-for-Profit Corporation, adopts the following Articles of Amendment:

**ARTICLE I**

The name of the corporation is Boca Raton Bromeliad Society, Inc.

**ARTICLE II**

The following Amendment was adopted by the corporation:

“The name of the corporation shall be changed to BROMELIAD SOCIETY OF THE PALM BEACHES, INC.”


**ARTICLE III**
