Title

ARTICLE III

The objects and purpose of the Not for Profit Corporation is organized exclusively for charitable, educational, religious or scientific purposes within the meaning of Section 501© (3) of the Internal Revenue Code:

- 1 To engage in the business of providing life skills training, counseling and services to enhance the standard of living of low income children and families in Seminole County, Florida.
- 2. To reach, teach and nurture youth and families who desire a better outlook on life.
- 3. To empower youth and families with positive stable minds that will enable them to increase self-esteem, self-respect and self worth.
- 4. To engage in all other lawful businesses.
- 5. To make and enter into all contracts necessary and proper for the conduct of its business or businesses.
- 6. In general, this not for profit corporation shall have and exercise all the powers conferred by the laws of the State of Florida upon not for profit corporation. It is hereby expressly provided that the foregoing enumeration of specific powers shall not be held to limit or restrict in any manner such general powers.

ARTICLE VI

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c) (3) of the internal Revenue code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose. Any such assets not disposed of shall be disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
