

ARTICLES OF INCORPORATION

These Articles of Incorporation are made pursuant to Chapter 617 Florida Statutes Not For Profit Corporation.

ARTICLE ONE

1. The name of the Corporation shall be Ravens Baseball Club Inc., a Florida Not For Profit Corporation.
